- (iv) Withhold or refuse to return any document in the form of certificated of degree, diploma, or any other award or other document deposited with it by a person for the purpose of seeking admission in such institution with view to induce or compel such person to pay any fee or fees in respect of any course or Programme of study which such person does not in lead to pursue,

- (v) Demand of money in excess of that specified in the declared admission Policy or approved by the competent authority to be charge by such institution.
- (vi) Breach of Policy for reservation in admission as may be applicable.
- (vii) Complaints of allege discrimination by students from schedule caste, scheduled Tribes OBC, women minority or disable categories.
- (viii) Non payment of delay in payment of scholarships to any students that such institution is Committed under the conditions imposed by AICTE or by any other authority.
- (ix) Delay in conduct of examinations or declaration of results beyond that specified in academic calendar.
- (x) On provision of student amenities as promised at the time admission or required to be provide.
- (xi) Non transparent or unfair evaluation practices.
- (xii) Harassment and victimization of students including sexual harassment and
- (xiii) Refund of fees on withdrawal of admissions as per AICTE instruction from time to time
