with it by a person for the purpose of seeking admission in such

institution with view to induce or compel such person to pay any fee or fees in respect of any course or Programme of study which such person does not in lead to pursue, Demand of money in excess of that specified in the declared admission Policy or approved by the competent authority to be charged by such institution.

- (xii) Breach of Policy for reservation in admission as may be applicable.
 - (xiii) Complaints of allege discrimination by students from Scheduled caste, Scheduled Tribes OBC, women minority or disable categories.
 - (xiv) Nonpayment or delay in payment of scholarships to any students that such institution is Committed under the conditions imposed by AICTE or by any other authority
 - (xv) No provision of student amenities as may have been promised or required to be provided by the institution
 - (xvi) Denial of quality education as promised at the time admission or required to be provided
 - (xvii) Non transparent or unfair evaluation practices.
 - (xviii) Harassment and victimization of students including sexual harassment and any other matters affecting the dignity of person.
