

## ANNEXURE

### NORMS FOR SELECTION OF CANDIDATES UNDER QUOTA FOR EMINENT SPORTS PERSONS

1. The purpose of this quota is to recognise and give weightage to the sports eminence of the candidates and hence marks for sports achievements alone will be considered in ranking the candidates. The candidates are expected to show good performance in sports, if selected.
2. Selection of the candidate will be based on the marks obtained by the candidate, following the guidelines given in the table below :

### Category A & B Sports Disciplines :

A sports discipline where there is provision for winning more than one Gold / Bronze / Silver in a tournament is classified under Category A and the rest under Category B, for the award of marks for achievements / participation.

#### (a) For International Tournaments:

**Category I :** Olympics, World Cup / World Championship, Commonwealth Games, Asian Games, Asian Championships, Junior World Cup / World Championships, Asian Junior Championships, World School Games and South Asian Federation Games.

**Category II :** All other International tournaments not covered under Category I.

1. Participation / achievement in International tournaments will be considered only with earlier achievements at National / State level tournaments.
2. Only tournaments officially recognized by the Indian Olympic Association / respective official National Federation will be considered (for each year) for the award of marks.
3. Participation / Achievements in tournaments, with Form I alone are eligible for marks indicated in table of item 2 above.

#### (b) For National / South Zone Tournaments :

1. Only one annual tournament under each category officially recognized as the regular annual championship tournament by Indian Olympic Association/ SDAT/ SAI / respective official National Federation will be considered (for each year) for the award of marks.
2. Participation / achievements in Meets (such as Zonal Meets, with Form II), which are pre-requisite for the corresponding National Meets are eligible for marks under participation only.

### 2 For State Tournaments :

Only one tournament under each category officially recognized as the regular annual championship tournament by TNOA / SDAT / respective State Association will be considered (for each year) for the award of marks.

3. For consideration of Candidates seeking admission under the category of eminent sports person, he/she should enclose attested photocopies of participation certificates and the Forms issued by the relevant sports authorities, along with the application.
4. National / State Level Sports/ Games conducted by organizations recognized by Indian Olympic Association / Sports Development Authority of Tamil Nadu (SDAT) / Tamil Nadu Olympic Association (TNOA) alone will be considered for award of marks. (Recognition should be relevant to the year concerned.)

5. The relevant attested copies of certificates issued by the appropriate authorities as detailed below are to be submitted along with the application.

These certificates are not valid unless signed personally by the authorities mentioned above :

6. Open / Individual tournaments of any kind will not be considered.
7. For Tennis, the achievements of top three players by his/her position in the ranking list published by AITA/ TANTA based on the ranking rules and the final rankings of previous four years, for each category, will be awarded marks for achievements & participation (necessary forms from associations are to be enclosed).
8. For Cricket, the annual official championship tournaments conducted within the country under the auspices of TNCA / BCCI at District / State / National Level alone will be taken into consideration for that year.
9. The participation / achievements of candidates with nativity of Tamil Nadu who represented Tamil Nadu alone are eligible for marks under National category.
10. All the achievement certificates are to be supported necessarily by the relevant participation certificates and appropriate Forms as indicated in table under item 5.

11. No further enclosures or certificates will be entertained after the last date for submission of completed application form.
12. Only Tamil Nadu candidates are eligible to apply for admission under Sports Quota and only the KVS schools within Tamil Nadu are eligible for marks under Table III of item 2.
13. A Common Committee constituted for this purpose will rank the candidates based on the marks assigned to the certificates enclosed along with the application.
14. Required number of candidates will be called to appear for an interview before the Common Committee for verification of the originals, followed by counselling after ranking.
15. If any candidate fails to produce the requisite original certificates and Forms, his / her place will be allotted to the candidate next in rank and so on. The consequential vacancy at the end of the rank list will be filled up from among the additional candidates, according to their ranks.
16. Selected candidates will be counselled for allotment of branches and colleges earmarked for this quota, based on the above ranking before the start of the main counseling as per the norms.
17. The decision of the Common Committee shall be final.
